The Political Science & Public Administration Wing, Directorate of Distance Education (DDE), Annamalai University is organizing a two day National Seminar on **"MULTI-DIMENSIONAL PERSPECTIVES OF HUMAN RIGHTS IN THE MODERN MILLENNIUM: REFORMATIVE STRATEGIES AND MECHANISMS"** to be held on 27<sup>th</sup> & 28<sup>th</sup> February, 2019. The National Seminar will focus on current issues and challenges on human rights in this 21<sup>st</sup> Century.

### About the Institution

In the early 1920s Rajah Sir S. R. M. Annamalai Chettiar founded Sri Meenakshi College, Sri Meenakshi Tamil College and Sri Meenakshi Sanskrit College at Chidambaram. In 1928, Rajah Sir S. R. M. Annamalai Chettiar agreed with the Local Government to handover the above said institution for establishing a University. Thus, on 01.01.1929 Annamalai University was established as per Annamalai University Act 1928 (Tamil Nadu Act 1 of 1929). One of the most significant developments is the enactment of the Annamalai University Act, 2013 (Tamil Nadu Act 20 of 2013), which has come into force from September 25, 2013. Annamalai University is accredited with 'A' Grade by NAAC in 2014. "The NIRF-2018" by the Ministry of Human Resource Development (MHRD) has ranked the University in the band 101 - 150 in the overall category as well as the University Category. In the Pharmacy Category the ranking is 20th in India. In the Medical Category the ranking is 24th. "The Times Higher Education World University Ranking - 2019" has ranked Annamalai University in 1000+ for overall category. In the Subject Category Ranking, 2019, the University is ranked in the band of 501-600 for Life Sciences and Pre-clinical, Clinical & Health Subjects. 800+ in the Physical Sciences subject. "The QS World University Ranking - 2019" has ranked Annamalai University in the band of 291 - 300 in Asia Ranking, 174 in the BRICS Ranking and 43 in India Ranking. "The CWTS Leiden Ranking 2018", on scientific impact of universities and on universities' involvement in scientific collaboration & scientific performance, has ranked the University at 20th based on the number of publications and 4th based on the proportion of publications that, compared with other publications in the same field and in the same year, belong to the top 10% most frequently cited. "The MDRA - India Today Ranking" (2018) has ranked Annamalai University 13th among the best Government Universities in India. Among the top 197 ranked institutions for Higher Education in India the "SCImago Institutional Ranking (2018)" has ranked Annamalai University as 7th in Tamil Nadu and 32nd in India. Annamalai University is one of the largest unitary, teaching, and residential Universities in Southern Asia comprising of 10 Faculties and 49 Departments of Study. This University has played a pivotal role in providing access to higher education to thousands of youth cutting across the social spectrum, especially from economically and socially disadvantaged classes. In this respect, this University's service to the nation is tremendous.

### The Directorate of Distance Education

The Directorate of Distance Education established in 1979, and now offers more than two hundred different programmes of study under the Regular Stream. It is credited with the largest enrolment in India and is well equipped with computer and other infrastructure, adequate teaching faculty and administrative set-up of its own, study centres, computers training centres, etc., to serve its students' clientele in their best interest at their door steps. It has also the unique distinction of offering first in India - Postgraduate Degree Programmes in Applied Psychology, Physics,

Chemistry, Zoology, Botany, Bioinformatics and Law through Distance Education mode. The Directorate of Distance Education is also offering the Programmes on Fashion Design, Textile Design, Interior Design, Hotel Management and Catering Technology Programmes, Retail Management, Twinning Programme, Programmes on Health Science, Yoga, Music, Fire and Safety.

### Political Science & Public Administration Wing

In recent times, one of the emerging and significant fields of research among the social scientists is Human Rights. Though the concept of Human Rights is included in the Fundamental Rights of the Indian Constitution, there are allegations of violations by the state and its various agencies. The past records and available literature on Human Rights indicate that the weaker sections of the society namely, women, children, downtrodden, tribals, etc., have been subjected to exploitation over the years by the individuals and institutions. No doubt that the Indian Constitution and laws enacted have various provisions to protect the Human Rights. Besides the above, the establishment of Human Rights Commissions at the national and state levels has further strengthened the institutional framework to safeguard the human rights.

However, of late, there is a growing apprehension among the scholars that the existing framework and the protective mechanisms have not satisfactorily achieved the objectives for which they were created. To address these issues, social scientists have analysed the problems of human rights from the perspectives of social, economic, political, legal, cultural and psychological dimensions.

Hence, there is no dearth of research and literature on various aspects of human rights. But mostly these researches focus on only few well known aspects of the problem of human rights like, child labour, women rights, refugee rights, police brutalities, female infanticide, discrimination against SCs, STs, Transgender rights etc., while neglecting some of the important, sensitive and urgent issues like, treatment of labourers in unorganized sectors, harassment in prisons, illegal detention, domestic violence, violation of copy rights, character assassination and perjury open trial in the media, cybercrimes, crimes against women, NGO's role in the cause of human rights, etc. In this context, this National Seminar on Human Rights focuses on the following sub-themes:

3. Font Style: Times New Roman, Font Size: 12, Line spacing: 1.5 Space.
4. The paper should neither exceed 12 pages not less than 6 pages.
5. References in APA style.
6. Plagiarism is strictly denounced.
7. Undertaking must be given by the author(s) declaring the originality of the work.

The contributor(s) should provide their Name/s, Affiliation, Mailing Address, E-mail ID and Phone Number along with their Paper.
