GENERAL INSTRUCTIONS FOR APPLICANTS:

1. The posts are being advertised keeping in view the broad areas of specialization in subjects. However, the Departments concerned may have specific requirement of specialization.

Merely fulfilling the minimum qualifications or the eligibility criteria does not entitle an applicant to be necessarily considered or called for interview.

2. All appointments made shall be provisional and subject to verification of certificates through proper channel. The University may verify the documents and antecedents of the applicant at the time of appointment or anytime during the tenure of the service. In case it is found at any point of time that any documents / information submitted by the candidate is false or the candidate has suppressed any relevant information, the services of the selected candidate shall be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of Indian Panel Code for production of false certificates.

Consequent upon adoption of self-certification provisions as promoted by the Govt. of India, the University shall process the applications entirely on the basis of information/documents attached with the application. In case the information/documents are found to be false/incorrect by way of omission or commission, the responsibility shall lie solely with the applicant and the applicant shall be liable for action as per law.

3. All correspondence from the University including interview call letter, if any, shall be sent only to the email address provided by the applicant in the online application form. The candidates are advised to check the website of the University regularly for updates.
4. Canvassing in any form will be treated as a disqualification.
5. Applications which do not meet the eligibility criteria given in this advertisement and / or are incomplete in any respect shall be summarily rejected.
6. The number of posts advertised may vary, and the University reserves the right not to fill up some or all posts advertised.
7. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after issuing an appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the applicant.
8. In case of any dispute/ambiguity that may occur in the process of selection, the decision of the University shall be final.

10. Before applying for a post, candidates are advised to satisfy themselves about their eligibility. No enquiry in this regard will be entertained.
11. The selection shall be based on the performance of candidate in the interview.
