Notice Inviting Quotation for Auction No. 13/2024

Name of Work: Removal of dead kikar tree from Vice-Chancellor's Residence cum Camp office at CUH Campus.

General public is hereby informed that the 01 no. dead kikar tree will be auctioned on 17/01/2024 at 10:30 AM in the office of the Executive Engineer, Room No.-217, Administrative Building, CUH campus.

Terms and Conditions:

- 1. Those who wish to participate in the auction, should deposit an EMD of Rs 1000/- (Rupees One Thousand only) in the form of NEFT/RTGS in favour of Central University of Haryana's Account No. 7824000100000392 IFSC Code: PUNB0782400 (Punjab National Bank, Jant-Pali, Mahendergarh). The bidder must submit the proof of the EMD deposited before participating in the auction process.
- 2. The item shall be sold to the higher bidder.
- 3. It is the responsibility of the bidder to visit the site, to inspect and satisfy themselves about the tree before participating in the bid.
- 4. Successful bidder (H-1) has to submit 100% of the quoted amount before taking out the tree from the CUH campus.
- 5. Tree must be cut including removal of its roots, without any damage to the nearby properties within 3 days of receiving the permission for the work.
- 6. GST or other taxes as applicable will be charged extra.
- 7. CUH holds all the power to cancel the auction at any point of time
- 8. The EMD of unsuccessful bidders will be returned to them without any interest after finalizations of sale/work order to the successful bidder.
- 9. No items, once auctioned, from the successful bidders shall be taken back by CUH on any condition whatsoever.
- 10. The highest bidder (H-1 bidder) should deposit 100% of the amount on the same day, failing which the entire deposited EMD will be forfeited.

- 11. The tree should be removed & cleared away from CUH premises within 03 days from the date of issue of permission letter. If the bidder fails to clear the site within 03 days, the storage charges @ 100/- per day will be levied on the bidder maximum upto Rs 1,000/- (Rs One Thousands), after that the bidder will not be allowed to take any material and the whole amount deposited by the bidder shall be forfeited.
- 12. Copy of PAN Card & Adhar card is required to be provided at the time of auction.
- 13. For the loading/ unloading, shifting of the materials, the purchaser shall engage their own personnel only and shall keep CUH indemnified against any claim whatsoever including for wage, injuries, compensation, death etc.
- 14. It is responsibility of the bidder to take any permission if required form the statuary bodies at his own level.
- 15. The successful bidders should bear the charge/fees payable for conveyance, etc.
- 16. No labor below the age of 18 years be employed on site.
- 17. All T&P required will be arranged by the contractor.
