



**MEMORANDUM OF UNDERSTANDING**

Between

**National Institute of Food Technology Entrepreneurship and Management  
(NIFTEM), Sonipat Haryana**  
And

**Central University of Haryana (CUH), Mahendragarh, Haryana (India)**

The National Institute of Food Technology Entrepreneurship and Management (NIFTEM), Sonipat Haryana and Central University of Haryana (CUH), Mahendragarh, Haryana (India) agreeing on the effective cooperation and experimental participation in the field of academics, training and research enters in to this Memorandum of Understanding (MOU).

The Memorandum of understanding (MoU) made in NIFTEM on 13, April 2021 between:

1. **National Institute of Food Technology Entrepreneurship and Management (NIFTEM)** (Deemed to be University (De-novo Category) under Section 3 of the UGC Act, 1956 An Autonomous Institution under Ministry of Food Processing Industries, Government of India) Sonepat, Haryana, India (herein after referred to as "NIFTEM" the context otherwise requires include their respective nominees, legal representatives and successors); and
2. **Central University of Haryana (CUH), Mahendragarh, Haryana India** set up by an Act of parliament: "The Central Universities Act, 2009" by the GOI (herein after referred to as "CUH" the context otherwise



requires include their respective nominees, legal representatives and successors).

#### **Scope of MoU:**

This MoU details the modalities and general conditions regarding collaboration between NIFTEM and CUH for enhancing within the country, to promote the research cooperation between the two institutes.

#### **Objectives**

1. NIFTEM and CUH will undertake joint research work in the areas of mutual interest.
2. The concerned scientists of NIFTEM and corresponding faculty members of CUH will formulate research projects with due approval of both the institutes.
3. Impart training to staff, students and technical personnel within the areas of cooperation.
4. Keeping in view the interest and objectives of both the institutes, NIFTEM and CUH will take initiative in writing collaborative extramural grant proposals to agencies in India and abroad.

#### **Sharing of facilities**

Both NIFTEM and CUH jointly agree:

1. To share their respective important research and development (R&D) facilities in order to promote research interactions in the areas of cooperation. The institutes agree to share software, other materials and components developed in-house in the areas of cooperation.
2. To share laboratory, animal house, library and other supporting facilities to the personnel cornered in the areas of cooperation.

3. To share research results in the areas of cooperation. Institute will communicate the results together in the form of publications/patents or other forms of intellectual property.
4. Both the parties shall meet their respective expenses which they might incur while carrying out their respective agreed obligations.

#### **Renewal of the MoU**

It is agreed that the progress of this MoU shall be monitored by the review committee comprising the Vice Chancellor, NIFTEM and the Vice Chancellor, CUH or their respective nominees through periodic joint meetings. In case there is nothing to the contrary, this MoU shall continue to get renewed automatically, for the next term of 3 (three) years after the completion of one term. Any mid-term change/ alteration in the terms and conditions of this

MoU as suggested by the review committee, if mutually agreeable to the heads of the both the organizations shall also be deemed to be valid for both the organizations for the rest of the duration from thereon. The MoU may be amended from time to time by mutual consent of both the parties. The MoU may be terminated by either of the parties by giving one month's notice.

#### **Intellectual Property Rights**

The results of the work produced through the joint efforts of the parties under the terms of this MoU will be jointly owned. Disclosure, if any, of any such results to the parties outside this MoU will only be done with the separate agreements of both the parties. Rights regarding publications, patents, royalty, ownership of software/ design, product and process developed etc/ under the scope of this MoU shall be decided by the two parties on mutual consent.

### Dispute Resolution







**Subject: Extension of MoU between NIFTEM-Kundli and Central University of Haryana**

This is with reference to the Memorandum of Understanding (MoU) executed between National Institute of Food Technology Entrepreneurship and Management, Kundli (NIFTEM-K) and the Central University of Haryana, Mahendergarh (CUH) on 13<sup>th</sup> April 2021, for an initial duration of three years.

There is a renewal clause stipulated in the MoU which is represented as:

“In case there is nothing to the contrary, this MoU shall continue to get renewed automatically, for the next term of 3 (three) years after the completion of one term. Any mid-term change/alteration in the terms and conditions of this MoU as suggested by the review committee, if mutually agreeable to the heads of both the organizations, shall also be deemed to be valid for both the organizations for the rest of the duration from thereon. The MoU may be amended from time to time by mutual consent of both the parties. The MoU may be terminated by either of the parties by giving one month's notice”

In view of the above clause, and with mutual agreement between NIFTEM-Kundli and CUH, it is hereby confirmed that the MoU stands extended for a further period of three years, i.e., until 13<sup>th</sup> April 2027, under the existing terms and conditions.

This letter is signed by the Registrars of both institutions as a formal record of mutual consent for the extension of the said MoU. This MoU shall remain in force upto 13<sup>th</sup> April 2027 on the terms and conditions as stipulated in the MoU.


