(LATERAL ENTRY SCHEME) 2024-25

Department of Printing and Packaging Technology under the School of Engineering and Technology, Central University of Haryana organizes open counseling for admission in B. Tech.-2nd Year (3rd Semester) Program against vacant seats/leftover through **Lateral Entry Scheme**.

ELIGIBILITY FOR ADMISSION:

- Passed Diploma (Engineering) examination with at least 45% marks (40% in case of candidates belonging to reserved category) in any branch of Engineering and Technology.

IMPORTANT DATES:

Submission of documents by the candidate (Physically): August 20, 2024 (till 11:00 am)

Entrance Examination : August 20, 2024 (at 11:15 am)

Display of merit cum admission list : August 20, 2024 (1:00 PM)

Fee Deposit : August 20, 2024 (5:00 PM)

Venue: Room No. 216, 2nd floor, SoET Block, CUH Mahendergarh (Haryana)

METHOD OF SELECTION: Since the number of seats is limited, admissions will be offered strictly based on Entrance Examination merit.

FEE: The candidates are required to deposit the same tuition fee and other dues as applicable to the candidates admitted in B. Tech. in the session 2024-25.

IMPORTANT NOTE:

1. Candidates having any pending backlog in the qualifying degree (diploma) shall not be considered for admission.
2. In case of a tie among candidates securing equal marks in the merit list, the same will be broken by the following criteria:
 - a. Candidate senior in age shall rank higher in order of merit.
 - b. In the case of a tie in percentage of marks in the qualifying examination also, a candidate securing higher percentage of marks in matriculation/secondary or equivalent examination shall rank higher in order of merit.

3. All admissions will be made on provisional basis. If at any stage, any information furnished by the candidate is found to be fabricated or false, his/her admission will be cancelled.
4. Candidates appearing in the final exam of the qualifying degree are also eligible to apply. Such candidates have to furnish the following undertaking at the time of counseling. *“I am applying on my own risk and responsibility as my final result of the Qualifying Exam has not been declared.*

I do hereby declare that I do not have any backlog paper in any of the previous semesters (Years) of study of the qualifying exam and also, I do not expect any backlog in my final exam.

I assure you that I will produce the proof of passing of my Qualifying Examination with the minimum percentage of marks required on or before September 30, 2024, failing which my admission shall stand canceled and I shall not claim any right on any count whatsoever.”
