- The merit list is provisional subject to fulfilment of eligibility and verification of documents.
- Student need to login the portal (<https://cuhcuet.samarth.edu.in/pg/>) and do the needful by paying the fee. (06-07-2026, Monday, 04:55 PM)
- Student need not to come physically to the university at this stage. Dates for document verification will be notify by the department separately.
- The list is provisional and subject to verification of original documents, eligibility conditions, and other admission requirements.
- Inclusion of a candidate's name in the merit list does not automatically guarantee admission. Admission shall be confirmed only after successful document verification and payment of the prescribed fee within the stipulated period.
- Candidates are required to complete all admission formalities within the specified schedule. Failure to do so may result in cancellation of the allotted seat.
- If any discrepancy is found in the information provided by a candidate, the candidature/admission shall be liable to cancellation at any stage.
- The University reserves the right to revise, modify, or withdraw the merit list in case of any error, omission, or subsequent verification.
- Seats remaining vacant due to non-reporting, cancellation, or non-payment of fee may be offered to the next eligible candidates as per the approved merit and admission rules.
- Candidates are advised to regularly visit the University website and admission portal for updates regarding counselling, seat allotment, fee payment, waiting lists, and other admission-related announcements.
- Any dispute arising out of the admission process shall be subject to the jurisdiction and rules of the University.

- The decision of the University regarding admissions shall be final and binding on all candidates.
- In the event of a tie in the CUET score, the tie shall be resolved in accordance with the University's Tie-Breaking Policy (Revised General Instructions for Online Registration (CUET-2026)- Annexure-I), and the seats shall be allotted accordingly.
- “*” represents the category of candidates who have now been offered admission under Unreserved category. Those who have offered a seat and taken admission under the respective category/ies in the previous list are excluded from this list.
- If candidates from the waiting list fail to respond, it will be offered to the next candidates in particular merit.
