## GENERAL INSTRUCTIONS

1. All the candidates are advised to go through the minimum eligibility criteria and Admission rules of the University available on the University Website.
2. All the interested candidates willing to participate in On the Spot Counselling on 19-08-2025 for admission to vacant/leftover seats in various PG programmes, must have to register themselves from 14-08-2025 to 17-08-2025, irrespective of whether they had previously registered for regular/ open counselling or not.

3. **Registration is mandatory** for all the interested candidates who are willing to participate in On the Spot Counselling on 19-08-2025. **No registration fee** is required at this stage for any course or category.
4. **The candidates** who have earlier registered on the SAMARTH Portal for previous rounds counselling for the PG programmes are required to **register afresh** using a **different email ID** for On the Spot Counselling.
5. All the candidates registered for On the Spot Counselling (from 14-08-2025 to 17-08-2025) shall have to report in the concerned Department, in Physical mode or through Online mode, as per the schedule with all the required documents/certificate in original alongwith one set of photocopy.
6. All the provisionally admitted candidates shall have to confirm his/her admission by paying the Registration Fee (If applicable) and Academic Fee of the respective programme, as per schedule given above, failing which the offer of admission will be cancelled and the seat will be offered to the candidate next in the waiting list.
7. Seat(s) may increase or decrease, as per the availability on the day of On Spot Counselling. Candidates are requested to keep visiting the University Website for updated information.
8. The merit list of candidates reported during the On the Spot Counselling shall be prepared as per the preference given below:
  - i. The candidate(s) having valid CUET-2025 score shall be given first priority for admission.
  - ii. Candidate(s) who do not have valid CUET-2025 score but meet the minimum eligibility requirement for the programmes concerned, shall be given second priority for admission.

9. The comprehensive merit list, list of admitted and waiting list candidates shall be prepared and displayed on the Departmental Notice Board & University Website for information of all concerned.
10. In case seat(s) remain vacant in a particular category due to non-availability of candidates, those seat(s) may be converted into another category, as per the Admission Rules of the University.
