Applications are invited on prescribed format (attached as Annexure-1) from the registered Chartered Accountants/Firms who are interested to offer their services as chartered Accountants for the Central University for Haryana for a period of two year.

## Details of required works are as under:

- (a) Preparation of Annual Accounts & Balance Sheet on Double entry System as per Govt. of India Rules on computer/online system and preparation of financial statements as per Ministry of Education proforma, along with data entry.
- (b) Quarterly e-TDS Return, filing and generation of Form 16, 16A and 16B etc.
- (c) Preparation and certification of Utilization Certificates for various types of Projects and Schemes etc.
- (d) All matters related to Trade Tax.
- (e) Income Tax Returns of Central University of Haryana and all others income tax issues.
- (f) All types of GST work (Monthly, quarterly and yearly).
- (g) Resolution of queries of the Audit Team during their visit in the University and resolution of audit paras raised if any by the Audit team from time to time.
- (h) Re-conciliation of entries with bank statements, TSA, Ledgers as per requirement for making annual accounts in the Tally software.
- (i) Submission of the Balance Sheet by April 30 of the Financial year.
- (j) Any other work related to accounts assigned from time to time.



- (k) Full time deputation of an accounting personal (minimum B.Com. as Education Qualification and sound knowledge of Tally) to carry out the computerised accounts entry work for the University at the Central University of Haryana Campus.
- (I) All computerised entry of the bills/vouchers on daily basis.
- (m) Submission of the monthly report for discrepancies.
- (n) Visit by the Senior CA for scrutiny of ledgers/vouchers at least once in a fortnight.

#### Terms and conditions

- (a) The applicant CA/Firm should have at least 03 years working experience in the accounting as well as statutory audit.
- (b) The applicant CA/Firm will have to give a PPT presentation before the Committee constituted for the purpose on the date and time specified/notified by the University. The CA/Firm will be empanelled/hired on the performance/basis of the presentation. The presenter of the PPT must be a CA himself or partner CA of the Firm.
- (c) The term of hire/empanelment may be extended beyond one years on mutual consent on satisfactory performance.
- (d) The applications alongwith letter of acceptance of all the terms and conditions and Financial Bid must reach the Office of the Registrar latest by 12.10.2022 (2:00PM). The applicants must attach all the documents related to their registration as CA/Firm, work experience, annual turnover etc. alongwith the application form. All document in the sealed envelop must be submitted to the following address before 2:00PM on 12.10.2022.

- (h) The Financial bid will be opened only for the firms shortlisted in presentation. Hence, **it should be submitted in a separate sealed envelope** mentioning Total Yearly Fee and Applicable Taxes (if any).
