	In pursuance of above, a Committee was constituted to propose amendments in the Statute-11 relating to the constitution of the Executive Council and term of office of its members. As per the approved recommendations of the Committee, the proposed amendments were placed before the Executive Council for consideration and approval (58 th meeting, through circulation). The Council approved the same and the amendments were submitted to MoE on SAMARTH Portal.
