MEMORANDUM OF UNDERSTANDING (MoU)

BETWEEN

CENTRAL UNIVERSITY OF HARYANA MAHENDERGARH

AND

MAHILA MAHAVIDYALA JHOJHU KALAN (CHARKHI DADRI)

FOR

STUDENT EXCHANGE PROGRAMME FACULTY EXCHANGE PROGRAMME

This Memorandum of Understanding (hereinafter MoU) is made and entered into on day of February, 2023 between the Central University of Haryana having its premises at Villages Jant-Pali, Mahendergarh, Haryana-123031 (hereinafter referred as CUH/1st Party) on the one part and the Mahila Mahavidyalaya (Charkhi Dadri) having its premises at Village Jhojhu Kalan, District Charkhi Dadri, Haryana (hereinafter referred as M.M., Charkhi Dadri/2nd Party) on the other part.

Brief Description about parties.

Central University of Haryana is one of the Youngest Central University established under the Central Universities Act, 2009 of the Parliament. The University has been accredited with 'A' Grade in the first cycle of NAAC assessment and accreditation in 2017. The University has been listed among the top 151-200 University in NIRF ranking. The University is fully funded by the University Grants Commission (UGC). The Campus of the University is situated in 484 acres of land at Villages Jant – Pali, District Mahendergarh, Haryana. Presently the University offers 83 academic programmes (UG / PG / Research). The University is on the path of development with new thinking, mutual cooperation and partnership. The University is making special efforts for the education of the students as well as for skill development, research-innovation as well as developing opportunities for employment generation.

Approval of Affiliating University/Management may also be procured by the College please for entering into MoU. However, if there is as such no statutory bar to this effect, MoU can be entered into present form. Mahila Mahavidyalaya, Jhojhu Kalan is one of the finest institute for Women Education established in 2005. The college is situated in 15 acres of land at Jhojhu Kalan Village, Charkhi Dadri district of Haryana. This institute got Government Aid in 2009 for two academic courses (B.A./ B.Com). Besides these two courses, the institute have one UG Programme (BSc (N.M)), five P.G. certificate Programmes (M.Sc. (Chemistry), M.Sc. (Physics), M.Sc. (Geography), M.A (Hindi), M.A. (Pol. Sc.)) and one P.G. Diploma course (Yoga Science) in Self Finance Scheme (S.F.S). The Institute have three smart classes, one Language Lab, one Computer Lab, two Physics Labs, two Chemistry Labs, two Geography Labs, one Commerce Lab, fully digital Library, one sports Gym and one The Institute is on the path of development with mutual multipurpose Hall. cooperation and partnership. The College is making special efforts for the education of the girl students (especially rural area). The college is engaged in skill development opportunities for employment generation.

Both the parties believe that close co-operation with each other would be of major benefit to the students' community to enhance their skills and knowledge, hence both parties agree to collaborate with each other on the following areas:

- The CUH can give valuable input in teaching / training methodology, so that the college students fit into the demands of industry and corporate world which they would like to join after graduation.
- 2. The CUH can permit the Faculty and Students to visit its Campus and also involve in Faculty exchange on mutual terms and conditions to be finalized separately. The exposure provided to students and faculty through this association will build confidence and prepare the students to meet the challenges which they might have to face in future. The CUH can provide Workshops / FDPs for the hands on training of the teachers.
- 3. The CUH agree to carry out joint research activities in the areas of social science and allied studies on mutually agreed terms and conditions.
- 4. The CUH can train the students on the emerging technologies in order to bridge the skill gap and make them ready for Corporate World.
- 5. The college expect the necessary support from the faculty of the CUH to deliver Guest Lectures to the students in the department of Social Science, Languages, Science and Commerce, if available and permitted by the University.
- 6. The CUH can train the faculties of this College for imparting quality education using high technology and latest tool of instruction through Faculty Development Programmes.

Time:

Entry into effect, modification and termination:

 This MoU shall become effective on the date it is signed by the parties and shall be valid for 3 years. The period and validity of this MoU may be further extended by mutual consent.

- 2. This MoU may be amended by mutual written agreement and may be terminated at any time by either party upon written Notification by the Competent Authority of the Party initiating termination. Such Notification must be given to the other Party at least one month in advance from the effective date of termination.
- 3. All joint activities not completed at the expiration or termination of the MoU may be continued until their completion under the terms of this MoU.

Outcome:

The Central University of Haryana and Mahila Mahavidyalaya will develop collaboration in the area of Education, Research, Employment generation, Students Exchange and Faculty Exchange.

In witness thereof, the parties have executed this MoU and agreed to the terms and conditions contained herein.
