WHEREAS

A) First Party is a Higher Educational Institution named:

- C) First party and Second party believe that collaboration and operation between themselves will promote effective use of each of there resources & provide each of them with enhanced opportunities.
- **D)** The parties intend to cooperate and focus their efforts on cooperation within area of Single Use Plastics & Garbage Free (zero waste to landfill) and Clean Green & Pollution Free campus in befitting manner.
- E) Both parties, being legal entities in themselves desire to sign this MoU for advancing their mutual interests.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS Mou, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1 CO-OPERATION

- 1.1 Both parties are united by common interests and objectives, and they shall establish channels of communication and cooperation that will promote and advance their respective operations within the institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for each other
- 1.2 First Party and Second Party will facilitate effective utilization of the intellectual capabilities of First party providing significant input to them in developing suitable environment to develop clean and green environment, keeping in mind the needs of the today's world, the Second Party.
- 1.3 The general terms of cooperation shall be governed by this MoU. The parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all

Along with the Definitive Documents. This MoU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2 SCOPE

2.1 That both parties will work together for attaining and sustaining the goal of 'Single Use Plastics Free- Zero Waste to Landfill and clean – Green & pollution free campus' in a befitting manner.

2.2 That the party -II will provide technical/ handholding support to the party -1 for the developing and execution of a low cost and sustainable waste management models for attaining and sustaining the **Single Use Plastics** Free- Zero Waste to Landfill Campus.

2.3 That the Party-II will provide facilities/ technical and administration support to the students (Party -I) for the successful completion in their internship in environment-related activities.

2.4 That both parties agreed to extend support of subject experts/ resource persons/ administrative teams/infrastructure to each -other as and when required for conducting capacity building programmes i.e. trainings, workshops, seminars, symposiums, camps, exposure visits, experts lectures and developing of various behavior change IEC materials, training module and material development and documentation.

2.5 That both parties agreed to share the logistic support as and when required for conducting capacity building programmes successfully i.e. training, workshops, seminars, symposiums, exhibitions, camps, exposure visits, expert lectures, and behavior change IEC activities on environment protection & conservation including water, air, soil, sanitation & hygiene, health and safety from time to time.

2.6 That the Party-II will provide handholding support and conduct various training programs sessions survey field studies and behaviour change awareness activities for stakeholders on waste management, sanitation & hygiene, water resources management and safety on 'no profit- no loss' basis. Accordingly, modalities for "no profit- no loss' may be workout mutually by the both Parties under ambit of this MoU from time to time

Accordingly, modalities may be workout mutually by the both Parties from time to

time.

2.8 That the record of all activities including trainings/IEC activities and other related works

should be maintained in systematic manner.

2.9 That the names of both Parties will be advertised equally for the activities to be conducted

under the ambit of this MoU.

2.10 That the parties may terminate MoU with prior notice of three months in writing which will

be served at the registered address of opposite party.

2.11 That terms of MoU may be edited as per need with mutual consent of both parties in written.

2.12 That the both Parties will execute the various activities under this MoU on 'no profit-no loss'

basis in the greater interest of community and each other.

2.13 There is no financial commitment on the part of the Central University of Haryana,

Mahendergarh, the First Party to take up any programme mentioned in the MoU. If there is any

financial consideration, it will be dealt separately.

CLAUSE 3 INTELLECTUAL PROPERTY

3.1 Nothing contained in this MoU shall, by express grant, Implication, Estoppel or otherwise,

create in either Party any right, title, interest, or license in or to the intellectual property (including

but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

CLAUSE 4 VALIDITY

4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually

agreed terms, during which period Green Earth Kurukshetra, the Second Party, as the case may be,

will take effective steps for implementation of this MoU. Any act on the part of Training Partner

or Green Earth, the Second Party after termination of this Agreement by way of communication,

correspondence etc., shall not be construed as an extension of this MoU.

CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that First Party and Second Party are acting under this MoU as independent entities, and the relationship established under this Moll shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations, or to create any obligation or liability. expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having any authority under the terms of this MoU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

5.2 Settlement of Disputes-The parties shall first use reasonable endeavors to amicably settle disputes arising out of or in connection with this MoU. Where a dispute has not been amicable resolved the parties shall enter into structured negotiation with the assistance of a mediator acceptable to both the parties.

When mediation fails the parties shall settle the dispute through arbitration, such arbitration shall be conducted under the amended rules of Arbitration and Conciliation Act as amended up to date. The award of arbitration shall be final and binding upon both the parties. The venue of arbitration shall be at Hisar and the arbitration proceeding shall be governed by the amended Arbitration and Conciliation Act as amended up-to-date. The High Court of Punjab and Haryana Chandigarh and the court subordinate to it in Haryana shall have exclusive jurisdiction concerning this MoU including any matter arising out of the arbitration proceeding or any award therein.

- **5.3 Force Majeure** Either party shall promptly notify the other party, in writing, of any situation or event arising from circumstances beyond their control, which they could not have reasonably foreseen, and which make the performance of all or any part of the parties' obligation under the contract impossible. Upon notification of the occurrence of such a situation or even, the performance of this contract shall be deemed to be postponed for a period of time equivalent to that caused by the Force Majeure and reasonable period not exceeding one week thereafter shall be allowed for remobilization to continue the performance of the contract.
- 5.4 Confidentiality-Partners agree that they each use confidential, sensitive information to achieve their individual business goals. Due to the nature of the parties' business & intent to establish a working relationship together, confidential information may be shared between the parties. The parties agree to keep all confidential information and trade secrets in the strictest of confidence during the working relationship. Parties may not share any confidential information with unauthorized third parties.

CLAUSE 6 ENTRY INTO EFFECT, MODIFICATION AND TERMINATION

6.1 Duration of the Memorandum- The MoU is signed initially for a period of three years which will be effective from date of signing of MoU. The stipulated period of MoU may further extend up to 3-5 years, however, this extension shall be purely on the basis of mutual consent of both parties. Both parties shall review the status of the MoU at the end of every two-year period to determine any modification, whenever necessary. All joint activities not completed at the expiration or termination of the MoU may be continued until their completion under the terms of this MoU.

6.2 Implementation- All laws, rules and regulations issued by the parties shall be strictly observed at all times. No amendment or modification of the MoU shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to be amendment of the MoU. The modifications/changes shall become part of the MoU and shall be effective from the date on which they are made/executed, unless otherwise agreed to.

6.3 Termination of Memorandum- The MoU may be terminated with immediate effect by mutual agreement between the parties or by either party giving the other not less than six months' notice in writing.

The MoU has been executed in two originals, one of which has been retained bt the First Party and other by the Second Party.

6.4 Legal Effect- Nothing in this memorandum shall be construed as creating any legal relationship between the institute. This memorandum is a statement of intent to faster genuine and mutually beneficial collaboration.

IN WITNESS WHEREOF, the parties have executed this MoU on 12th September, 2025, and represent that they approve, accept and agree to terms contained herein.
