MINUTES OF MEETING NAAC STEERING COMMITTEE

A meeting of the NAAC Steering Committee was held online on 21-03-2022 at 07:00 P.M and was chaired by Hon'ble Vice Chancellor, in Gurugram Office of the University. Most of the members were present in the meeting.

At the outset the Hon'ble Vice Chancellor highlighted the importance of the NAAC Steering Committee keeping in view the preparation of NAAC Self Study Report for the NAAC Re- Accreditation 2022 cycle. He emphasized that we are required to submit the self study report within 30 days of the submission of IIQA and for which consolidated efforts are required to be undertaken by this committee as well as the other members which can be co opted for different committee of NAAC. He took one of the certain examples to explain as to what is the requirement during preparation of Self Study Report. Apart from this following points were discussed and resolved as under:-

- The Coordinators of the each committee is required to form a Team of 5-6 members and submit the same to Hon'ble Vice Chancellor by 22-03-2022. One of the members shall be from Branch/Section from where information is required to be collected for those criteria.
- 2. These teams will keep meeting frequently and prepare the Self Study Report within the time frame.
- 3. System Analyst along with some more manpower will be attached with NAAC office to extend IT related help to team preparing Self Study Report as capacity building of IQAC/NAAC.
- 4. The Team Members for Committees may include contractual Faculty/ Administrative staff as per requirements of the criteria.
- 5. The Steering Committee will review the Self Study Report preparation process frequently atleast once in a week.

6. The members who have prepared AQAR may also be taken in team so that information links are easy available and their expertise can be utilized.

Many Faculty members gave their views/suggestions regarding student feedback, Alumni Association, syllabus information gaps, mismatch of Data in AQAR and Self Study Report and such other matter's. At the end Hon'ble Vice Chancellor thanked all the members and sought whole hearted support in preparation of Self Study Report of the University and NAAC accreditation process.
